



### South Australian Government VET Student Enrolment Privacy Notice

Skillinvest are required to collect and report statistical data in relation to the training they have delivered. This mandatory reporting obligation is known as total Vocational Education and Training (VET) activity for Registered Training Organisations (RTOs) and must be fulfilled in accordance with the <u>National VET Data Policy</u>.

The AVETMIS Standard provides the national framework for the collection of VET training activity. AVETMISS is a national data standard that ensures consistent and accurate capture and reporting of VET student information. The National Centre for Vocational Education Research (NCVER) is the custodian of the Standard. For more information on AVETMISS refer to the NCVER website <a href="ncver.edu.au">ncver.edu.au</a>. The Department will use and disclose all data collected in accordance with all applicable legislation, including but not limited to, the Student Identifiers Act, the Privacy Act, and the National VET Data Policy.

### Why we collect your personal information

As a registered training organisation (RTO), we collect your personal information so we can process and manage your enrolment in a vocational education and training (VET) course with us. We use your personal information to enable us to deliver VET courses to you, and otherwise, as needed, to comply with our obligations as an RTO.

We are required by law (under the National Vocational Education and Training Regulator Act 2011 (Cth) (NVETR Act)) to disclose the personal information we collect about you to the National VET Data Collection kept by the National Centre for Vocational Education Research Ltd (NCVER). The NCVER is responsible for collecting, managing, analysing and communicating research and statistics about the Australian VET sector. We are also authorised by law (under the NVETR Act) to disclose your personal information to the relevant state or territory training authority.

The NCVER will collect, hold, use and disclose your personal information in accordance with the law, including the Privacy Act 1988 (Cth) (Privacy Act) and the NVETR Act. Your personal information may be used and disclosed by NCVER for purposes that include populating authenticated VET transcripts; administration of VET; facilitation of statistics and research relating to education, including surveys and data linkage; and understanding the VET market.

The NCVER is authorised to disclose information to the Australian Government Department of Employment and Workplace Relations (DEWR), Commonwealth authorities, State and Territory authorities (other than registered training organisations) that deal with matters relating to VET and VET regulators for the purposes of those bodies, including to enable:

- administration of VET, including program administration, regulation, monitoring and evaluation;
- facilitation of statistics and research relating to education, including surveys and data linkage;
- understanding how the VET market operates, for policy, workforce planning and consumer information.

The NCVER may also disclose personal information to persons engaged by NCVER to conduct research on NCVER's behalf. The NCVER does not intend to disclose your personal information to any overseas recipients. ## Consent for collection, use or disclosure of personal information (applicable if Skillinvest is applying for a USI on your behalf).

The information you provide through the USI application process is collected by the Student Identifiers Registrar for the purposes of:

- processing your application for a USI.
- verifying and providing a USI
- resolving problems with a USI and creating authenticated Vocational Education & Training (VET) transcripts.

#### This information may be disclosed to:

- a number of organisations, departments, regulators and other persons where it is reasonably necessary for the purposes of performing functions or exercising powers.
- the Oversight Authority in instances pertaining to digital identity to enable them to perform their functions.
- current and former registered education and training providers to:
  - o enable them to deliver VET and Higher Education courses.
  - o meet their reporting obligations under the VET and Higher Education standards and government contracts.
  - o assist in determining eligibility for training subsidies and higher education funding.
- schools for the purposes of delivering VET courses to you and reporting on these courses.
- the National Centre for Vocational Education Research (NCVER) for the purpose of:
  - creating authenticated VET transcripts
  - o resolving problems with USIs
  - o collecting, preparing and auditing national VET statistics
- researchers for education and training related research purposes.
- any other person or agency that may be authorised or required by law to access the information.
- any entity contractually engaged by the Student Identifiers Registrar to assist in the performance of his or her functions in the administration of the USI system and will not otherwise be disclosed without their consent unless authorised or required by or under law.

In all cases where I suffer an illness or injury of a serious nature and need medical attention, the emergency contact listed on this enrolment form will be informed.

### **Training**

I understand that as an enrolled student, I am bound by Skillinvest's policies and processes, as the Registered Training Organisation. I will attend all scheduled training sessions whether on or off the job. If I am unable to attend a training session either on or off the job, I will notify Skillinvest's trainer. I will complete all training and assessment requirements within the timelines negotiated upon course commencement and recorded on the training plan. I will notify Skillinvest of any change of address and/or contact details.
